ABAN and MSMT Serve Senior Citizens of Tapasthali Bridhasram



The Association of British Alumni in Nepal, in cooperation with Mrigrendra Samihana Medical Trust, has served 22 old aged ladies plus 4 staffs housed in the Tapasthali Bridhasram in Chapali, Budhanilkantha, Kathmandu on March 2, 2017.

When ABAN Executive Committee member Mrs. Padma Vaidya visited the Bridhasram on January 11, 2017, they requested for daily food items like beaten rice, dal, cocking oil, sugar, cornflakes, chocolates, washing soap, detergent, and a variety of green vegetables. All these items and other readymade food items were handed over directly to each of the old ladies there by Dr. Mrigendra Raj Pandey and his team as well as ABAN executive members, namely Mr. Tulasi Uprety, Mr. Punya Paudel, Mr. Uttam Lal Pradhan, Mrs, Shiba Kafle and Mrs. Padma Vaidya led by ABAN president Mr. Maheswor Bhakta Shrestha and his wife Pramila.



Tapasthali Bridhashram, set up by Mrs. Bhargavi some 24 years ago in a five ropani plot of land, is presently looked after by Mrs. Nanu Aryal (photo) as chairperson and Mrs. Usha Chalise as vice chairperson.

The Association of British Alumni in Nepal had earlier served the Bridhashram in 2008 with food items, cloths and fruits in a similar gesture of service to the senior citizens.

ABAN is a tax exempt Association from income tax. However, other taxes like VAT on expenses, and other taxes are payable. So, the tax office requires audited accounts with audit report duly approved by the annual general meeting.

ABAN accounts of fiscal year 2015/16 have been duly audited and the 19th AGM held on 4 February 2017 has passed the audit report. Based on such approved reports, the tax office of the government has issued a recommendation letter for renewal of ABAN's registration with the District offices.

The registration certificate of ABAN will now be renewed and updated after several years of backlog in this regard.

MSMT Awards ABAN on its 42thAnniversary Mrigendra Samjhana


Medical Trust celebrated its 42nd anniversary on 27th February 2017 in the presence of national poet

To celebrate the 19th Annual General Meeting on the ABAN Day of February 04, 2017, ABAN Magazine 2017 was published and released by the chief guest of the occasion Dr. Jiba Raj Pokhrel, Vice Chancellor of NAST, who described it as having an attractive cover and very insightful contents. So, he likes the magazine from Cover to Contents.

The contents of the Magazine cover messages of HM British Ambassador of Britain HE Richard Morris, Country Director of the British Council Dr. Jovan Ilic, President of Nepal-Britain Chamber of Commerce Mr. Rajendra K. Khetan; annual activity report, some facts about Nepal- Britain relations and insightful articles by the past presidents, president and life members of ABAN. Dr. Suresh C. Chalise and Mr. Deepak Thapa of the Kathmandu Post have so eloquently depicted the 200 years of Nepal-Britain relations, which is based on mutual trust understanding, goodwill and cooperation. The magazine included 14 topical articles, statute, audit reports, PAN/ Tax clearance, Registration certificates and other documents about the Association.

The ABAN Magazine 2017 has generated Rs.220,500/- advertising revenue (including Rs.60,000 yet to be collected) as surplus to the ABAN fund, because the cost of printing the magazine was fully paid for by the British Council. This is the highest contribution by any publications so far in the history of ABAN.

The Magazine has thus successfully helped to tighten the relations between Nepal and Britain, while at the same time has significantly strengthened the financial health of the Association.
