### ABAN ECM Awards Honorary Membership to Dr. Mahodadhi Pradhan Shrestha

Fifth meeting of 10th Executive Committee of ABAN held on October 27, 2017 has decided to award **Honorary Membership** to Dr. Mahodadhi Pradhan Shrestha of Baneshwor, Kathmandu. She has made a cash contribution of Rs.500,000/- (five lacs) to support the activities of ABAN. Dr. Mahodadhi has become the second Honorary Member of ABAN this year after Dr. Mrigendra Raj Pandey (ID 500).

Dr. Mahodadhi's application for Life Membership of ABAN was also approved, with ID number 512, as she had completed her Diploma in Obstetrics from the Royal College of Obstetricians & Gynecologists, London in 1970-72. Subsequently, she was also elected a Fellow of the International College of Surgeons in Gynecology on July 10, 1985.

ABAN Statute 2064, article 1 section 7 (1) provides for honorary membership of ABAN by Executive Committee decision to any person contributing Rupees one lac in cash or equivalent financial assistance.

### **ABAN – MSMT Partnership to Serve Senior Citizens**

On a September 16 proposal of ABAN to further expand the mutual cooperation



between the Association of British Alumni in Nepal (ABAN) and Mrigendra Samjhana Medical Trust (MSMT) to offer services to the senior citizens, school support with scholarship program and support to Rotary Heart Hospital in Patan, MSMT has responded positively on October 22, 2017.

The message confirms that MSMT executive committee has principally agreed to further expand the services to senior citizens in collaboration with ABAN. But the committee meeting decided to keep the extra fund needed for this purpose in its own account separately and the interest earned from this fund will be used for such services with ABAN.



"In this contest, we would lik to inform you that MSMT is willing to collaborate with ABAN to the services of the

senior citizens by providing additional medicine or food item if ABAN decides to undertake such services to senior citizens more than one time per year" the message reads.

As per an MOU signed on January 30, 2017, MSMT has provided an endowment fund of Rs.500,000 for regular services to senior citizens and Rs.30,000 separately to service the senior citizens of Tapasthali Bridhashram, Chapali on March 2, 2017 MSMT also provided food and medicine to Nisahaye Sewa Sadan on August 26 2017 in a joint program with ABAN.
