

Ninth Executive Committee Meeting Approves Dr. Mrigendra as 500th Member



ABAN Executive Meeting in Session



Association of British Alumni in Nepal (ABAN) is a not-for-profit social organization affiliated with

the British Council, active for the welfare of the Nepalese, who studied in UK and pursue an interest in the socio-economic development of Nepal.

ABAN also works for the cultural and educational exchange between Nepal and Britain.

The ninth meeting of the 9th Executive Committee of ABAN held on September 29, 2016 at ULCI, Dillibazar discussed the following agenda items for decisions:

Renewal of ABAN Registration

It was informed that ABAN tax clearance has been completed for three years till FY 2071/72 and has also been registered with KMC Ward no. 15 office at Lainchour, which has recommended for renewal of ABAN registration. District Development Committee Kathmandu office required audit report of FY 2072/73 as well to recommend for renewal of registration with CDO office.

Talk Program

A talk program is proposed on October 23, when speaker Dr. Mrigendra Raj Pandey, the newest Life Member joining ABAN, will share his experience of British education. Interested other Life members and past presidents of ABAN are requested to make presentations on topics relevant to their profession and UK- Nepal relations.

Fund Raising Activity

The Committee decided to publish **ABAN Magazine 2016** (Issue no.8) as a commemorative issue for celebrating Britain-Nepal 200 years and also as a fund raising tool of the Association through the collection of advertisements. A five member Magazine publication subcommittee was formed with Mr. Punya Paudyal as Coordinator.

Each member of ABAN will strive to collect advertisements, as a source of revenue, and quality articles relating to British- Nepal Relations, socio-economic and educational aspects of Nepal within December and edit/print during January for distribution on the proposed ABAN Day celebration on February 5, 2017. Support of British Embassy and British Council will also be sought in this venture.

The sub-committee met on October 3 and discussed the principles and modalities of collecting relevant articles and supportive advertisements for the ABAN Magazine.

Dr. Mrigendra Raj Pandey Joins ABAN as Life Member



Dr. Mrigendra Raj Pandey, who is the first MRCP physician of Nepal, joined the Association of British Alumni in Nepal as Life Member on September 29, 2016 and has become the

newest and 500th member. He completed his DTM&H (England) in 1957, MRCP (Edinburgh) in 1959, FRCP in 1969 and FFPHM (UK) by Distinction in 1992.

Dr. Mrigendra Raj Pandey is Regional Advisor of Royal College of Physicians of Edinburgh in Nepal and a recipient of **CVO** (Commander of Victorian Order) honor from **Her Majesty Queen Elizabeth** the second. In Nepal, the government has honored him with highest awards like Om Ram Patta, Trisakti Patta Class I, Gorkha Dakchhin Bahu Class I.

After the highly acclaimed British degrees in medicine and work experience of about 2 years in British hospitals, Dr. Mrigendra Raj Pandey served in Bir Hospital to revolutionize modern medical practices in the country including the establishment of ICU and CCU in Bir Hospital as early as in 1974. One of his cherished memories is the beginning of Post graduate medical education program in Nepal with the help of consultant from the Royal College of Physicians, UK.

Dr. Mrigendra Raj Pandey has served as Royal Physician for a long period of time and has helped establish a strong medical links with British hospitals and other institutions.

Bicentennial Stories

Personal stories celebrating 200 years of Britain-Nepal Relations

Col JP Cross was born in Britain in 1925. He joined the British Army in 1943 and first came to Nepal in 1947. He served in various locations, and eventually retired after 39 years. He spent the final years of his military service in Pokhara, Nepal and decided to stay. He became a Nepali citizen in 2015.



"It has been 71 years since I first joined hands with Nepalis. I am now 93 years old. There is not much time left for me now. I have become used to living in Nepal and with Nepalis, I feel carefree here. I like it here. This is what the God seems to have scribed for me".

"I was very proud when I got the Nepali citizenship. It is not something that you get easily. I am delighted, proud and happy to be a Nepali. I don't love this place anymore than before. It is my place now. I am honored guest. Likewise, my relations with Britain and the British is just the same. Being from two cultures means two clocks on the wall. The clock on the top shows Nepal time and the bottom clock which was given to me in the First Gurkha Rifle in March 2015 in the 200th anniversary, shows UK time".

Col Cross is a prolific writer. He is currently working on his 20th book. "I have had 19 books on grammar, autobiography, jungle warfare, novels, and a quick take and now I am trying to write 20th book."

Cross lives with his surrogate son and his family in Pokhara. He walks for four hours in the morning. He talks to dozens of people on the way. "Part of the family"

Bicentenary of Anglo-Nepal War and Treaty of Peace

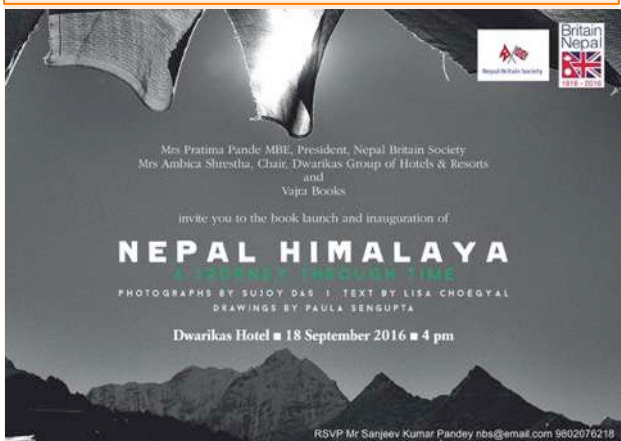
